

# Liability Waiver and Parental Consent Form



To Whom It May Concern:

I understand that skateboarding can be a dangerous activity and that, by participating in skateboarding as a competitor or a member of the media, I am assuming all risks of injury, even death. I hereby assume all the risks described above, even if **Sk8-Strong**, agents or representatives, through negligence or otherwise, could be deemed liable. I hereby release, waive, discharge this covenant not to sue Sk8-Strong, owners, employees, agents, participants, sponsoring agencies, sponsors, advertisers, *or any others associated with Sk8-Strong*; **I also release the City of Colorado Springs and the Parks and Recreation Division, the Pikes Peak Community Foundation and World Cup Skateboarding**, from any and all liability arising out of my participation in or presence at the skateboarding competition or event, even if the liability arises out of negligence that may not be foreseeable at this time. I understand, consent to and authorize, in advance, the use of my name, voice, picture or other likeness, in combination or alone, in any broadcast, telecast, print medium, advertising, promotion or other account of Sk8-Strong or events. I represent that my minor child, or I, are in sufficiently good physical condition to participate in the programs and activities of Sk8-Strong without jeopardizing our health. I understand that I have given up substantial rights by signing this waiver and release, and sign it voluntarily. This waiver and release also binds my heirs and assignees.

I agree that this RELEASE OF LIABILITY is intended to be as broad and inclusive as is permitted by law. Any provision found to be invalid or unenforceable by a court shall not affect the validity or enforceability of this, or any other provision. \_\_\_\_\_ (Initials)
